

#### CBIC Exam Development Cycle





How to prepare for a-IPC certification: Step 3

Develop a study plan and a timeline – work backwards from when you would like to take the exam.

### Helpful hints:

- Take a practice test. Use the results to determine where you should focus your studying.
- Review questions you answered incorrectly and **learn** from those questions.
- Review the <u>primary and secondary resources</u> used to develop the examination.
- Develop a study plan and dedicate time each day to reviewing content.
- Keep flashcards with you to study on-the-go.



### Helpful hints:

- •Join a study group! Learning with others can help with motivation. Celebrate your successes and help each other throughout the process.
- Follow the timing & break structure that is used on exam day
- Don't memorize **understand** the content!

### CBIC Candidate Handbook

- Candidates are responsible for reviewing the polices and information contained in the Candidate Handbook prior to applying for and becoming certified.
- Once a candidate has been approved to test, they are given a 90-day testing window.
- Schedule your appointment with Prometric (CBIC's testing vendor) as soon as you are approved to test. Appointments are first come first serve.
- Review the Prometric cancellation/rescheduling policy.

### Candidate Testing Experience

- •Candidates can take the exam at a physical testing center or via Prometric's live remote proctoring option, Pro Proctor
- •Testing is available 5-7 days a week depending on location







Prometric Testing Centers

- Located worldwide in 160+ countries
- Testing available 5-7 days a week during normal business hours
- Candidates are monitored throughout the exam in a secure environment





• Candidates can take the exam at home

#### Pro Proctor

- A live, remote proctor locks down the candidate's browser
- 360-degree environment check done of candidate workspace



### Exam day tips:

- If you are testing in a physical testing center confirm your appointment date and time and familiarize yourself with the directions to the testing center.
- If you are testing remotely, prepare your workspace and perform the Prometric system check BEFORE your appointment.
- Arrive at least 30 minutes before your testing appointment to ensure you do not miss your appointment.
- Make sure your government-issued identification is valid with your signature and photograph.
- Leave study materials at home. Do not bring these items into the testing center or have them at your workstation during a remote exam.




- Results are available immediately after submitting the post-examination survey.
- Passing candidates will receive a Pass message. No numerical scaled score is reported to passing candidates.
- Successful candidates should review information on the CBIC website on maintaining certification.
- Unsuccessful candidates will receive a score and performance level description.
